This is in continuation to the circular of even no. dated 13<sup>th</sup> April, 2023 regarding relaxation in time limit for Self-appraisal on SPARROW for APAR of the year 2022-23 vide which directions were issued to all concerned to fill self-appraisal by 30<sup>th</sup> April 2023.

However, it is observed that a substantial number of PARs are still pending at self-appraisal level. Taking due cognizance of the fact that PAR is an important document in matters of promotions & Career advancement of employees & also the practical difficulties that may have been faced by staff such as SSS in filling up the self-appraisal, it has been decided by the competent authority to extend the time limit for filling up the self-appraisal through SPARROW by 15 days i.e. 15.05.2023.
