The utmost attention shall be paid to the justification provided by the candidate. However, the decision of the Competent Authority of the Institute shall be final and binding to the candidate.

No separate communication to the candidate is being sent. Applicants whose name is not appearing in any of the list of Eligible and Shortlisted/Ineligible candidates means either their application has been received after due date or not received at all through E-mail.
