- 1. The interview for the above posts will be conducted through in- person at ICAR –CAZRI, Jodhpur/ online through video conferencing (*Scheduled date & time which will be intimated later on through phone/email/whats App* or *uploaded on institute website*https://cazri.res.in).
- 2. The interview will be conducted by strictly following COVID 19 guidelines given by Rajasthan state government / Government of India. All the candidates should follow the COVID 19 guidelines as such, if any deviation will not be allowed to attend the interview. No candidates will be allowed to enter ICAR-CAZRI campus withoutmask.
- 3. Only Indian citizens are eligible for appearing in the online/Walk-in-interview.
- 4. Candidate may choose the option of interview either in-person or online videoconferencing.
- 5. Age limit: Maximum age is 35 years with relaxation in case of SC/ST/OBC/Women as per existing rules as on last date of submission of application throughemail.
- 6. Period of contract service Up to 31thMar, 2021 or co-terminus of project whichever is earlier.
- 7. The above positions are purely temporary basis and is co-terminus with the project subject to satisfactory performance. The selected candidates shall have no right/claim for regular appointment or absorption at ICAR-CAZRI at any point of time.
